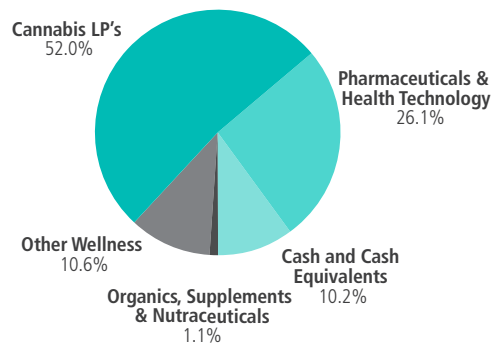
GROWTH OF \$10,000 INVESTED (AUG 04, 2017)¹
