**NOTES:**

- (1) A unitholder (investor) has the right to appoint a person to represent the investor at the meetings other than the management representatives named in this proxy. This right may be exercised by inserting in the space provided the name of the other person the investor wishes to appoint. This other person need not be an investor in either of the Funds.
- (2) To be valid, this proxy must be signed and deposited with **Broadridge Investor Communication Solutions, P.O. Box 3700, STN Industrial Park, Markham, Ontario L3R 9Z9** so as to arrive at least 24 hours (excluding Saturdays, Sundays and public holidays) before the start of the meetings or any adjourned, postponed or continued meetings, or the proxy may be deposited with the Chair of the meetings by the start of the meetings at the latest.
- (3) If the investor is an individual, this proxy must be executed exactly as the units are registered. For an individual investor who is voting on his or her own behalf, the investor has the option of voting by phone or by internet, in addition to the option of sending a signed proxy to Broadridge Investor Communication Solutions by mail, as described above. If the units are registered in the name of a deceased or other investor, the investor's name must be printed in the space provided, the legal representative must sign this proxy with his or her name printed below his or her signature and evidence of authority to sign on behalf of the investor must be attached to this proxy.

- (6) If units are held by two or more investors, any one of them may vote the units held, but if more than one of them are present or represented by proxy, all of these investors must vote the units together.
- (7) If this proxy is not dated in the space provided, it is deemed to bear the date the proxy was mailed.
- (8) **The units represented by this proxy will be voted in accordance with the instructions provided. However, this proxy confers discretionary authority on the designated management representatives. If no instruction has been given with respect to voting for or against the matters described above in this proxy, the management representatives will vote the units represented by this proxy FOR such matters. An investor or their proxy may only vote in respect of those Funds in which the investor holds units.**
