## WHY INVEST IN GOLD?

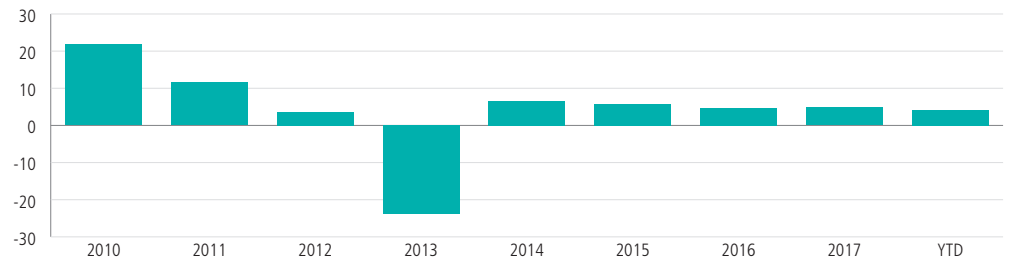

- Gold's unique fundamentals.

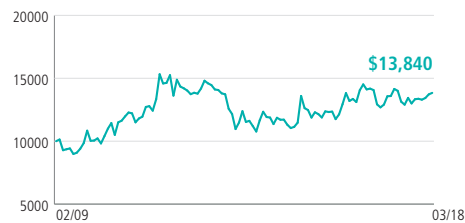
