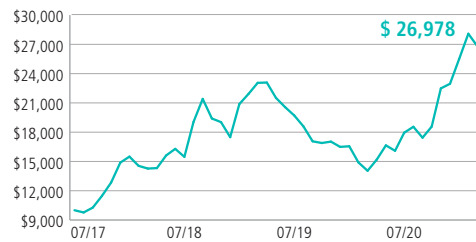
WHY INVEST IN NINEPOINT ALTERNATIVE HEALTH FUND?

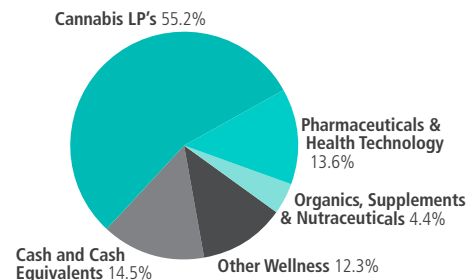
GROWTH OF \$10,000 INVESTED (AUG. 8, 2017)¹
