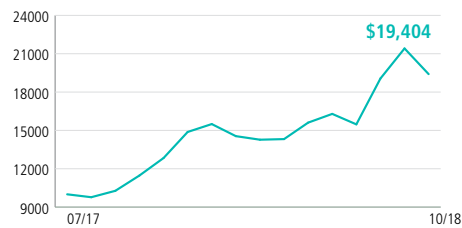
WHY INVEST IN NINEPOINT ALTERNATIVE HEALTH FUND?

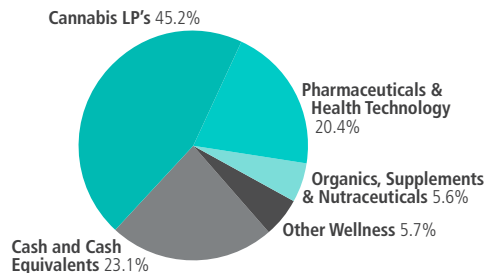
