

	Blockchain + Al	We believe that the future of AI will be decentralized and open-sourced, not siloed in the hands of Web2 giants.
	NFTs	We believe that unique digital assets will become widely deployed across cultural industries, and we seek ways to gain access to their success.
	Computing and Infrastructure	This next era will require vast computer power and other infrastructure, widening the scope of investment potential.
	Gaming	Gamers are already accustomed to paying for digital goods. With blockchain, they can own them.
	Metaverse/XR	We believe that metaverse is a new economic frontier which can be tapped into via the public markets.
