Unless otherwise specifically defined, the terms used in this amendment have the meanings given to those terms in the Simplified Prospectus.

1. Introduction

Effective November 3, 2025, the Simplified Prospectus is hereby amended to reflect a change in the name of the Fund from "Ninepoint Capital Appreciation Fund" to "Ninepoint Balanced+ Fund".

2. Technical Amendments to the Simplified Prospectus

The Simplified Prospectus is amended as described below to reflect that the name of the Fund will change from "Ninepoint Capital Appreciation Fund" to "Ninepoint Balanced+ Fund". The following technical amendments are made to the Simplified Prospectus to reflect this change:

- (a) The references to "NINEPOINT CAPITAL APPRECIATION FUND" on the front and back covers of the Simplified Prospectus are hereby changed to "NINEPOINT BALANCED+ FUND (formerly, Ninepoint Capital Appreciation Fund)".
- (b) All references to "Ninepoint Capital Appreciation Fund" in the Simplified Prospectus, other than on the front and back covers of the Simplified Prospectus, are hereby changed to "Ninepoint Balanced+ Fund".
- (c) Underneath the heading "NINEPOINT CAPITAL APPRECIATION FUND", on page 136 of the Simplified Prospectus, the words "(FORMERLY, NINEPOINT CAPITAL APPRECIATION FUND)" are added.

- (d) The ticker symbol referenced in the "FUND DETAILS" table on page 136 of the Simplified Prospectus is hereby changed from "NCAP" to "NBAL".
- (e) Underneath the heading "NAME AND HISTORY" on page 139 of the Simplified Prospectus, the following sentence is added as the last sentence:

"Effective November 3, 2025, the name of the Fund was changed to Ninepoint Balanced+ Fund."

WHAT ARE YOUR LEGAL RIGHTS?
